Sub: Lodging of FIR

Sir,

With due respect I SI Mahendra Lama, OC Melli OP, Kalimpong PS Dist Kalimpong would like to inform you that on 30.10.19 at about ^{14:30} hrs I received a telephonic information that a motorcycle and a Wagon R vehicle had met with an accident at Chihuribotay, NH-10 opposite side of Tribeni. I rushed to the spot and it could be learnt that one Pulsar NS 160 motorcycle bearing Regn No TC No SK/1/TR/2019/3783 and one Wagon R vehicle bearing Regn No SK 02P 3059 had collided head on as a result of which the rider of the said motorcycle namely Dawa Tamang (29 yrs) s/o P Tamang of Upper Sichay, Near Dist Court, East Sikkim sustained severe injuries on his persons and was lying on the side of the road. It could be learnt that the rider was and was coming from Gangtok side while the Wagon R was coming from Siliguri side. One passenger of Wagon R namely Lalit Kr Agarwal s/o Lt Prem Kr Agarwal of Geyzing, West Sikkim had also sustained minor injuries. With the help of local people both the injured persons were sent to Kalimpong Dist Hospital for medical treatment in critical condition. It could also be learnt that the said Wagon R was being driven with great speed in rash and negligent manner by Pankaj Kr Shah (26 yrs) s/o Om Prakash Shah of Kamalanagar, Salugara, PS Bhaktinagar, Siliguri.

Hence I pray that a specific case may kindly be initiated against the driver of the offending Wagon R vehicle bearing Regn No SK 02P 3059 namely Pankaj Kr Shah (26 yrs) s/c Om Prakash Shah of Kamalanagar, Salugara, PS Bhaktinagar, Siliguri under suitable section of law.
