As a result in a vehicle in which my son was travelling got damaged at the front side. As a result he was severely injured and was brought at Karbi B.P.H.C for his treatment but the attending Doctor declared him brought dead. In my opinion the accident took place due to the negligence of the driver of vehicle no-WB 73E 1706.


