Action taken if any and the result there on: The case was initiated on 16/04/2022 over the written complaint from complaint from Kamali Chettri D/o Om Bdr Chettri of dhobi dhara, Leprosy Road, PS Kalimpong to the effect that on 15.04.2022 at around 22.00 hrs her brother namely Dhan Bdr Chettri met with an accident against Vehicle WB73C 1627 at Pabung Busty under Kalimpong PS.

Ward Master District Hospital KPG Shri Pradip Paul Rai, complaint that on 16.04.2022 at 01.40 hrs one person brought dead at KPG Hospital over this KPG PS U/D Case No. 43/22 Dt. 16.04.2022 started. During investigation I PSI Alamgir Sarkar of Kalimpong PS prepared the Inquest report Over the dead body of the deceased namely: Dhan Kr Chettri (Male/Christianity /36Yrs), S/O- Om Bdr Chettri, R/O- Thakuri Compound, Laproscopy Hospital Road, Dhobi Dhara, Kalimpong, And forwarded to the Autopsy Sergeant District Hospital KPG through U/D Constable 310 Mukul Roy for holding P.M Examination to ascertain the actual cause of death.

During investigation it could be learned that on 15.04.2022 at around 19,00 hrs one Ford vehicle bearing no. WB 02AJ 5338 was at the middle of the road, at that point of time one Ambulance bearing WB 73C 1627 driven by Kishore Tamang S/o Yong Tshering Tamang of Rambi Bazar, PS Kalimpong along with the deceased namely was coming from Nimbung dropping one patient, Seeing the Ford vehicle stranded the driver of the ambulance approached the said FORD vehicle and tried to start but it couldn't get started, So Kishore Tamang along with the deceased left for Relly to get the mechanic Jahir Ansari, Jahir Ansari stated that the deceased was fully drunk and when the approached the place of occurrence, driver Kishore Tamang got down from the vehicle leaving the key of the vehicle in the dash board parking the vehicle in slight steep road facing towards Nimbung, the deceased too got down from the vehicle to urinate, and after urinating he entered in the driver's seat, When the driver and the mechanic were busy repairing the vehicle they heard loud sound and, when the driver looked back found his vehicle was not at the place he had parked, when the driver along with others rushed to the spot found his vehicle had dropped 30 ft. below the road. When Police and local people rush him to KPG Hospital the Doctor on duty declared him dead.

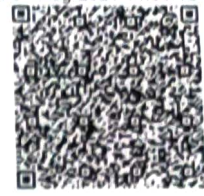
