

17. **Brief Facts of the case:-** The fact of the case in brief is that On 10.02.2022 one Dalu Ram Sharma S/o- Lt. Dilli Ram Sharma of Deogram, Teesta PS Kalimpong a written complaint to the effect that on 10.02.2022 at 18.05 hrs when he was proceeding towards Teesta Bridge found one kumar Chhetri is lying at Rabijhora having injury and one motorcycle and its rider also there then he brought the motor cycle and its rider to the teesta CP and handed over them and sent kumar chettri to the hospital for treatment. On the basis of the written complaint SI Tashi Tshering Sherpa of Kalimpong PS started Kalimpong PS C/No.29/2022 dt. 10.02.2022 U/S 279/338 IPC and endorsed me for its investigation.

During investigation I visited the PO, examined the available witnesses and recorded their statement U/s 161 CrPC. I seized the motor cycle along with its key and driving license and one Pranim Dahal under proper seizure list in presence of the witnesses duly signed by them. I arrested accused rider Pranim Dahal (20) S/O- Prem Prasad Dahal of 4<sup>th</sup> mile, Tashiding Busty PS Kalimpong on 10.02.2022 and forwarded him before the Ld. Court of CJM, Kalimpong on 11.02.2022. I send requisition to the RTO Kalimpong for examining the seized motor cycle technically to ascertain the actual case of accident. Sri D Adhikary, MVI (Tech), Kalimpong has examined the motor cycle on 08.04.2022 and opined that "Due to unstable or high speed driving accused bike found snidely damage on front head light assembly at the time of inspections". I collected the MVI report and kept in the record. I examined injured kumar chhetri S/O- Tej Bahdur Chhetri and recorded his statement U/S 161 CrPC. He was primarily treated at Teesta PHC and then referred to the Kalimpong District Hospital for better treatment. I collected his injury report from Teesta PHC and BHT from Kalimpong District Hospital.

Then accordingly I am submitting Charge Sheet in this case U/S 279/338 IPC against accused person **Pranim Dahal (20) S/O Prem Prasad Dahal of 4<sup>th</sup> Mile, Tashiding Busty PS Kalimpong arrested on 10.02.2022 and forwarded before the Ld Court of CJM, Kalimpong on 11.02.2022** vide Kalimpong PS Charge Sheet No. **162**./2022 dt.11.05.2022 to stand his trial in open court of law as the complicities on the part of the accused person has been well established. Supplementary Charge Sheet will be submitted on the event of any further development in this case. P/Ws may kindly be summoned to prove the fact during trial and seized articles may kindly be ordered to be put up in the Ld Court during trial.
