bus bearing no WB 71 6113. While entering Gorubathan the said bus met with an accident and hit one electric pole near Panda'a resulting few passengers got injured and was shifted to Gorubthan Hospital. She believes that the accident took place due to the negligence of the driver while driving the vehicle.

Over this written complaint, the instant case under reference was initiated and I took up its investigation.

During Investigation, I, covered up all formalities of investigation, Viz- Examined complainant, and other available witnesses in c/w the case under reference and recorded their statements u/s 161 Cr. P.C in a separate sheet of papers. Visited the P.O and prepared its rough sketch map with index. Seized the offending vehicle and documents of the vehicle. Served the notice U/S 133 mv Act to the power of attorney holder the vehicle to provide the details of the driver and collected the details of the same. Seized the damaged electric pole from the PO. Collected the mechanical examination report of the vehicle. I also collected the injury report of the 03 injured person from Gorubathan BPHC. Received an order from Ld CJM Kalimpong Court that the accused Biswajit Sarkar had surrendered before Ld Court on 27/01/23 and got released on bail. I then released the vehicle on 09/02/23 after receiving the Court order to release the vehicle.

I consulted the merit of the case with my Superior, who perused the case docket with its contents, and advised me to submit charge sheet against the accused person.

Hence, I am submitting charge sheet in this case vide Gorubathan PS Charge Sheet.No-06/23 Dt- 20/02/23 U/S-279/337/338/427 IPC against one Biswajit Sarkar (36) S/O Sushil Sarkar of Baganbari, PS Falakata, Alipurduar to stand trial in the open Court of Law.

The witnesses will prove the case during the time of trial.

The result of the investigation has been informed to the complainant of this case.
