

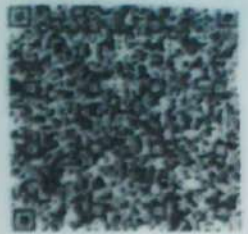

17. **Brief facts of the case.** The fact of the case is that on 11.03.2023 at 13.10 hrs. received a written complaint from one Laxuman Gupta S/O Lt. Gangaram Gupta of Suntaley Bazar, PS Reang, Dist. Kalimpong to the effect that on 10.03.2023 at around 22.00 hrs. when he returning from his duty, he found that on bricks loaded vehicle bearing Reg. No. WB73 D 8302 coming from Siliguri side, during overtaking met an accident near Lohapool under Reang PS, Dist. Kalimpong due to rash and negligence driving and fell down roadside jungle. As a result the driver of the vehicle and his helper sustained injury on their person and the vehicle was damaged also. Over this started Reang PS case No. 19/23 dated 11/03/2023 U/S 279/427/337/338 IPC and O/C Reang PS endorsed me for its investigation.

During investigation I visited the PO and prepared rough sketch map with index of the PO .I examined the complainant and all the available witnesses & recorded their statement U/S 161 Cr.PC .
