

As per order of Ld CJM, Kalimpong seized Wagon R car bearing Regd No. SK 01-P-2669 along with its all relevant documents except Driving License of deceased driver Nischal Thapa to Sri Parsu Ram Thapa S/O Lt Tek Bdr Thapa of Upper Bazaar, PHC Rangpoo PS- Rangpoo Dist-Pakyong, East Sikkim. Further investigation of the case I collected injury Report of patients 1. Avinash Gurung S/O Nar Bdr Gurung of Patle Baans, Singmari PS & Dist- Darjeeling and 2. Anurag Rai S/O Deo Prakash Rai of Badamtam PS & Dist-Darjeeling from PHC Rangpoo, East Sikkim and collected the Inquest Report along with PM Examination Report of deceased driver Nischal Thapa in C/W Rangpoo, Sikkim PS U/D Case No-22/22 Dt 24.12.22. In which Dr Taye Pem Lepcha opined that "Coma as a result of head injury due to road traffic accident". In course of investigation as well as the statement of the witnesses and documentary evidences it is well established that accident was occurred due to rash and negligently driving by car driver Nischal Thapa S/O Parsuram Thapa of Rangpoo Bazar PHC Sikkim succumbed his injury at PHC, Rangpoo, East Sikkim who died in the incident.

I consulted with my superior officer O/C Melli OP and I/C Kalimpong PS regarding the merits and demerits of the case. They perused the case dairies and advised me to submit Final Report in this case U/S 279/337/338/304(A) IPC.

Accordingly obtaining permission from my superior officer O/C Melli OP and I/C Kalimpong PS and as per their kind advised I submitting this Final report is True vide Kalimpong PS F.R.T No- 09/23 dt 31.01.23 U/S 279/337/338/304(A) IPC with a view to re-open the case if any clue will detect in future. The result of the investigation of the case being informed to complainant.
