



### FINAL DIAGNOSIS:

- HEAD INJURY WITH SCALP & ORBITAL REGION LACERATION & SCALP HEMATOMA
- BLUNT CHEST INJURY
- LEFT SHOULDER INJURY WITH FRACTURE OF CLAVICLE

### History of presenting complaints:

Patient was admitted with alleged H/o. RTA at around 11:30 am on 12.11.2022.  
C/o. Headache & chest pain with vomiting since then.

Clinical Findings on Admission: GCS: E4 V5 M6, BP: 90/60 mmHg, Pulse: 96/Min, Chest - B/L clear, PA - Soft, Pupils: B/L 1.5 mm, normally reacting to light, CVS: S1 S2 audible (+), CBG - 158 mg/dl, CNS - normal, afebrile, active pain

### Course of Treatment in Hospital:

Patient was initially managed in emergency room, examination & dressing of injury wounds was done, then shifted to Intensive Care Unit for further evaluation and management. She underwent radiology & hematology evaluations. Treatment started with IV fluids, antibiotics, neurotrophics, antacid, analgesic, antipyretics and other supportive measures. Orthopedician & OMF Surgeon were also consulted, Surgery for the management of her lacerated injuries was advised. After her significant stability, she underwent OMF Surgery on 14.11.2022. Post operative treatment continued with supportive measures. Surgery for management of Left Clavicle Fracture was also advised. After management and medication she improved gradually and she was discharged in a stable condition.

Nature of Injury: Nature of injury was Grievous
