Scalp hairs 1/2" long I/V puncture mark present over dorsum of both hands. Central line puncture mark present over Lt. side of neck.			
Injuries - (1) Old lacerated wound with features of healing, measuring 1" x 3/4" x tissue present over Rt. Forehead, 1" above midpoint of Rt. Eyebrow. (2) Old lacerated wound with features of healing, measuring 1 1/2" x 3/4" x tissue, present over Rt. Forehead extending from nasion. (3) Old lacerated wound with features of healing, measuring 1 1/2" x 3/4" x tissue, present over Rt. cheek. (4) Old lacerated wound with features of healing, measuring 1 1/2" x 3/4" x tissue present over Rt. Forehead, 1/2" lateral to Rt. eye. O/D Scalp, it was found edematous. One Metallic implant was found over Rt. Fronto-Zygomatic junction. Granulation tissue found in the subdural space of both side of parietal lobes. All the injuries are fresh and showing evidences vital reactions. No other external and internal injuries could have been detected over body after careful examination and dissection.
