

16. Brief Facts of the case: (Add separate sheet if necessary): The fact of the case in brief is that on 10/06/2023, a Sikkim towards Malbazar, P.S. Malbazar, Jhalpaiguri. The driver name Rupes Rai, the driver received a written complaint from Monu) parait s/o Rupen, Sikkim towards Malbazar the vehicle No. WB 74 BE 8079 coming from Mangon, Jhalpaiguri that the vehicle bearing no WB 74 BE 8079 coming from Mangon, Jhalpaiguri due to over speed and negligence of driver name Rupes Rai, the driver received minor injury and brought to Rambh Hospital for treatment but Doctor refer him to Siliguri for further treatment. One passenger who is nephew of the complainant, he is s/o O/C. Reang PS, I have taken up its investigation registered with Reang PS and on being endorsed the case to me by O/C. Reang PS, I have taken up its investigation.

During investigation I visited the PO prepared Rough sketch map and Index of the PO, Seize the Motor documents under proper seizure list. I seized the offending vehicle and to mechanically examine the offending the vehicle and give his valuable opinion. After examining the vehicle he opined that the accident occurred due to cause other than mechanical failure.

On 23.06.2023 I collected the injury report of the driver Rupesh Rai from Rambh Rural Hospital. The ME opined that the nature of injury is uncertain in Nature.

During investigation a prima facie charge U/S. 279/337/427 IPC has been well established against the named accused person driver namely Rupesh Rai (Male- 37 yrs) s/o Desh Bir Rai of Bus stand, PS-Malbazar, Dist. Jhalpaiguri.

Accordingly I consulted with my superiors O/C, Reang PS and C.I. Pedong, Kalimpong regarding merit and demerit of the case. They both instructed me to submit Charge sheet after pursuing of case docket. Hence, I submitted Charge sheet against Rupesh Rai s/o Da-hbir Rai of Bus Stand, PS- Malbazar, Jhalpaiguri under U/S No.21/23 dated. 30.06.2023 U/S 279/337/427 IPC to stand trial in the open court of law. The witnesses will give the case during the time of Trial. The result of the investigation inform to complainant.

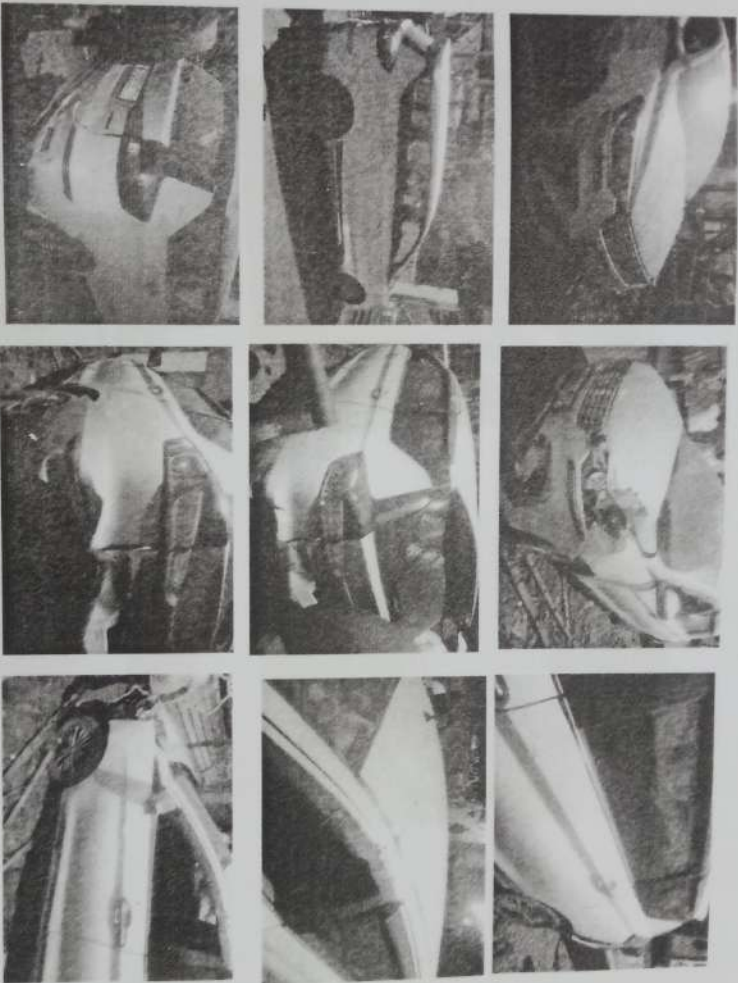


