The vehicle did not stop after injuring him. After one hour we reached at the spot and took him to Sharma Nursing Home (Hospital) at Kalimpong. The brief fact of the case: One Passang Tshering Tamang s/o- Dorjee Tamang of Samabyong Kashyone GP PO pedong PS+Dist- Kalimpong lodged a written complaint that his brother in-law namely Avinash Sharma s/o- Manoj Sharma of Champasari Siliguri who is working with GREF at 20th Mile sakyong pedong , on 17.04.2022 at about 20.00hrs pm he was going to purchase some items from nearby shopat 20th mile suddenly a unknown white colour vehicle going towards Algarah hit him near GREF camp and his left leg broken by the hit of the vehicle . The vehicle did not stop after injuring him .After one hour complainant reached at the spot and took the victim to Sharma Nursing home at Kalimpong .He could not noticed the vehicle number and did not recognized the driver after his injury Over this written complaint I/C Kalimpong PS started above noted case and endorsed to me for its investigation. Accordingly I took up its investigation.

Brief Fact of the case :- (Cont'd) :-

During investigation it reveals that on 17.04.2022 o at 20.00hrs one white coulor vehicle hit Avinash Sharma when he was going to Pedong to purchase some household items near GREF camp. As the victim was in drunk condition so he could not notice the vehicle no. He could say that vehicle was a in white colour.Thgeafter one Passang Tshering Tamang came at the spot and admitted him to Sharma Nursing Home ,Kalimpong.

In course of investigation I visited the PO and prepared rough sketch map of PO and index in separate sheet of paper. All available witness were examined and recorded their statement U/S-161 Cr.PCI also sent Form 54 within 48 hrs of FIR. I examined the victim Avinash Sharma and recorded his statement U/S- 161 Cr.PC.I also tried to search CCTV cameras from Pedong to Alagarh Bazar but could not fin out any cameras which covers the roads. I submitted requisition to OC Alagarah PP now LAVA PS and checked CCTV cameras installed in the traffic point of Alagarah Bazar but no fruitful result found. I collected injury report of victim from Sharma Nursing Home Kalimpong..


All possible efforts were made to trace the offending vehicle and its driver but all sincere efforts ended in smoke. It is very difficult to trace the the offending vehicle in near future as no any clue is available. And victim could not say about the no and type of vehicle.

I consulted the merits and demerits of the case with O/C Pedong PS and I/C KPG PS and they advice me to submit Final report a true U/S-279/338 IPC keeping the matter in view.

Hence I am submitting FRT Vide Kalimpong PS FRT No- 62 /23 Date -30.04.2023 U/S-279/338 IPC in this case keeping the matter in view for re-opening the case if any clue later on.
