17. **Brief fact of the case:** - The brief fact case is that on 15/06/22 at 11:15Hrs S.I Deepak Thapa O/C Melli OP under Kalimpong PS received information over telephone that an accident meet with two vehicles at near Maamkhola on NH-10 on received information he diarized the fact in Melli OP GDE No-320 Dt 15.06.22 and informed the fact to I/C Kalimpong PS over telephone and as per direction of I/C Kalimpong SI Deepak Thapa, O/C Melli op along with force left OP to work out the information. On arrival he found that two vehicles Zon Estilo car bearing Regd No-SK02P/0269 and Scorpio vehicle bearing Regd No-SK01PB/4637 lying on NH-10 near Maamkhola on damaged condition. With the help of local peoples and force SI Deepak Thapa O/C Melli OP manage to shifted the both damaged vehicles in the suitable space and traffic became under control. During local enquiry it could be learnt that the accident was occurred about 10:30 hrs due to rash and negligently driven by both vehicle drivers as a result total five persons including drivers sustained grievous injury and shifted them Rampoo PHC, Govt of Sikkim for their treatment. Over the written complaint of SI Deepak Thapa, O/C Melli OP I/C Kalimpong PS recorded the above noted case and endorsed me to investigate the case.

**Col No-17** : During investigation of the case I visited the PO, sketched the rough map of PO with index, examined all available witnesses and patients and recorded their statement U/S 161 Crpc, I seized the both accidental vehicles and its relevant documents under proper seizure list. After collecting sufficient evidences I served the notice U/S 41(A) Crpc to the both offending drivers 1.Chitraj Pradhan 39 yrs (Driver of said vehicle No SK 01 PB 4637 ) S/o Late Bhanu Pradhan of Rangpo Kumrek Busty PS Rangpo , East Sikkim and 2. Sanjay Kami 34 yrs (Driver of said vehicle No, SK02 P 0269)S/o Gopi Kami of Sisney Soreng PS- Naya Bazar, West Sikkim. According on my notice both the offending drivers had voluntarily surrendered before Ld court and released on court bail. Further investigation of the case examined the both accidental vehicle mechanically by mechanical expert Bholanath Baruri and as per order of Ld CJM,Kalimpong both the vehicles including its relevant documents to its present registered owner except Driving Licence under proper receipt. In coure of the investigation and as well as the statement of witnesses and as per documentary evidences a prima facie charge U/S 279/337/338 IPC has been well established against both vehicle drivers 1.Chitraj Pradhan 39 yrs (Driver of said vehicle No SK 01 PB 4637 ) S/o Late Bhanu Pradhan of Rangpo Kumrek Busty PS Rangpo , East Sikkim and 2. Sanjay Kami 34 yrs (Driver of said vehicle No, SK02 P 0269)S/o Gopi Kami of Sisney Soreng PS- Naya Bazar, West Sikkim involved in this case. I consulted my superior officers O/C Melli OP and I/C Kalimpong PS regarding the merits and demerits of the case. 

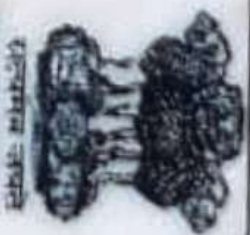
