Brief facts of the case: The brief fact of the case is that on 27.09.2022 received a written complaint from one Laxmi Thapa w/o Lt Badal Thapa of Dara Gaon, Jaigaon, Alipurduar to the effect that on 08.09.2022 she received information that her husband met an accident by unknown vehicle at Jorethang more, Melli under PS Kalimpong and succumbed his injury. Over this Kalimpong PS Case No. 263/22 Dt. 27.09.2022 u/s 279/338/304 A IPC has starte endorsed me for its investigation, accordingly I took up its investigation. During investigation of the case I visited the PO, Drew rough sketch map of the PO with index, Examined all available witnesses and recorded statement u/s 161 CrPC. Every efforts were made to detect the offending vehicle by searching CCTV cameras in the surrounding area,holding enquiry by examined the witnesses but, in vain. Non could say any about regarding the offending vehicle. Further investigation of the case I have collected Post Mortem Examination report from Melli PS,Sikkim of the deceased Badal Thapa dully certified to be true by SHO,Melli PS,Sikkim. In which Autopsy Surgeon of Namchi Govt Trict hospital opined regarding cause of death " Head injury with fracture" and "most probably due to accident but the actual cause of death is yet to be ascertained".

I consulted with my superior officer O/C Melli OP and I/C Kalimpong PS regarding the merits and demerits of the case. They perused the case dairies and advised me to submit Final Report in this case U/S 279/338/304(A) IPC.
