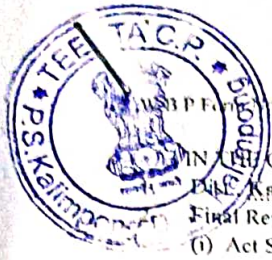

Brief fact of the case: - The fact of the case in brief is that On 01.04.2023 LSI Sabita Lama, OC Teesta CP received one written complaint of one JC-671035X Sub Maj Ajab Singh of 517 ASC Batallion, Gangtok ( Indian Army) to the effect that today (01.04.2023) morning their one army vehicle bearing Regd No 13D192441X was travelling from 5<sup>th</sup> Mile Gangtok to Sevoke through NH-10. At about 11.15 hrs at Geilkhola the vehicle plunged in to river Teesta. There were driver Sepoy 14880802 Thakor Rasangji Savji and co driver JCO 285731 Uday Veer Singh two person in the vehicle. Co driver Uray Veer Singh could be rescued and send to Kalimpong District Hospital for treatment but driver Thakar Rasangji Savji is still missing searchin operation is going on. On receipt of the written complaint LSI Sabita Lama has forwarded the written complaint to IC Kalimpong PS for starting a case vide Teesta CP GDE No.25 dt.01.04.2023. On receipt of the written complaint of JC-671035X Sub Maj Ajab Singh of 517 ASC Batallion, Gangtok ( Indian Army) Sri Sanjay Ghosh, IC Kalimpong PS has started Kalimpong PS C/No.36/2023 dt.01.04.2023 U/S 279/337 IPC and endorsed me for its investigation. He sent a copy of FIR to me.

During investigation previous I visited the PO, prepare rough sketch map of the PO with its index examined the available witnesses and recorded their statement U/S 161 CrPC. I seized the offending damaged vehicle bearing Regd No.13D192441X and other alamsats under proper seizure list in presence of the witnesses duly signed by them

**Contd-Col No. 17.** During search & rescue operation member of DMG Team could rescued dead body of missing driver Sepoy 144880802 Thakor Rasangji Savaji S/O Thakor Savaji Chhagagi of House No. 179, Tessil Vadnegar PS Vadnagar, Dist Mehsana, Gujarat on 05.04.2023 morning.

Over the dead body of Sepoy 144880802 Thakor Rasangji Savaji Kalimpong PS UD C/No. 24/23 dt. 05.04.2023 has been started and endorsed me for its investigation. I held inquest over the dead body prepared my investigation report U/S 174 CrPC. Forwarded the dead body to the Superintendent Kalimpong District Hospital for PM Examination to ascertain the actual cause of death. OC Teesta CP sent message to all ICs & OCs of Coochbihar/Alipurduar/Jalpaiguri and Siliguri Pc for discontinue the search as the dead body of missing Sepoy 144880802 Thakor Savaji has been rescued.

During investigation I could collect the PM Report of deceased Sepoy 144880802 Thakor Rasangji Savaji in C/W Kalimpong Ps UD C/No. 24/23 dt. 05.04.2023. I perused the same and found that Dr. Subhojit Paul, MO Kalimpong District Hospital held PM Examination over the dead body of deceased Sepoy 144880802 Thakor Rasangji Savaji in C/W Kalimpong PS UD C/No. 24/23 dt. 05.04.2023 on 05.04.2023 and prepare the PM Report in the Pm Report the autopsy surgeon opined that 'The cause of death is due to drowning ante mortem in nature. Time since death-Any time between 72 hrs to 96 hrs prior to PM Examination'. During investigation as per my requisition Sri S. Roy, MVI (Tech), Kalimpong examined the seized vehicle bearing Regd No. 13D192441X mechanically. He opined flowingly:

I have physically inspected the vehicle Registration Number 13D192441X in respect of Officer in Charge, Teesta Check Post. After proper inspection of the vehicle & examine all aspects, it is found that the vehicle damaged badly due to Mechanical failure and outline from NH-10 to Teesta River. I collected the mechanical examination report vide memo No. 84/MV/2023 Dated 04.04.2023.

I consult the case with IC Kalimpong PS he has instructed me for submitting Final Report in this case as the investigation is more or less completed. Hence I am submitting Final Report in this case U/S 279/337/338/304A IPC as True bide Kalimpong PS Final Report No. 144/2023 dt. 22.09.2023. As during investigation from the mechanical examination report of MVI (Tech) it has been established that the vehicle damaged badly due to Mechanical failure and outline from NH-10 to Teesta River. So charge U/S 279/337/338/304A could not be established against the deceased driver Sepoy 144880802 Thakor Rasangji Savaji S/O Thakor Savaji Chhagagi of House No. 179, Tessil Vadegar PS Vadnagar, Dist Mehsana, Gujrat. Hence he may kindly be shown discharge from this case. The case may re open if any traces and clues is obtained in near future.

Result of investigation of this case is being intimated to the complainant accordingly.
