

Subject: Hit-and-Run Incident.

Respected Sir/Madam,

I am writing to bring to your attention a serious hit-and-run incident that occurred on 3/12/2023 at 11:30 pm in GAILKHOLA, involving a Bolero pickup with the registration number WB 71 B 2302 and a Mahindra Bolero with the registration number WB 73 F 3052. The victim, Sumit Gazmer, son of Chand Gazmer, residing near Kumudini Homes School, Kalimpong, was severely injured in the incident and is currently hospitalized.

The driver responsible for the accident, as per the information gathered, is Mr. Dulal Sarkar, son of S. Sarkar, residing at 2 No jyoti Nagar, Isckon Mandir Road, Haider Para, W/No.40 (M.Corp), Siliguri. His driving license number is W873 20040317873.

The incident occurred when Mr. Dulal Sarkar, driving the Bolero pickup, hit both the victim, Sumit Gazmer, and another friend who was with him at the time. The impact resulted in Mr. Gazmer sustaining serious injuries, including a fractured leg. Additionally, his friend suffered injuries, albeit less severe, as he attempted to avoid the collision.

I, who was in the Mahindra Bolero with registration number WB 73 F 3052, attempted to apprehend Mr. Dulal Sarkar. Fortunately, he managed to locate him at 29th Mile, where Mr. Sarkar had gotten his vehicle stuck in a drain. When I approached him and questioned him about the hit-and-run, Mr. Dulal Sarkar reversed his vehicle and deliberately collided with my car.

Following the collision, Mr. Dulal Sarkar lost consciousness, and it appears he had no recollection of the events that transpired. I have attached photographs of the victim, Sumit Gazmer, and our damaged vehicle for your reference.

Considering the severity of the incident and the injuries sustained by the victim, I kindly request your immediate intervention to conduct a thorough investigation into this matter. The reckless actions of Mr. Dulal Sarkar have not only caused harm to individuals but also demonstrated a blatant disregard for the law.

I trust that the Reang Police Station will take appropriate measures to ensure justice is served in this case. I am willing to cooperate fully with any investigations and provide any additional information required.

Thank you for your prompt attention to this matter.



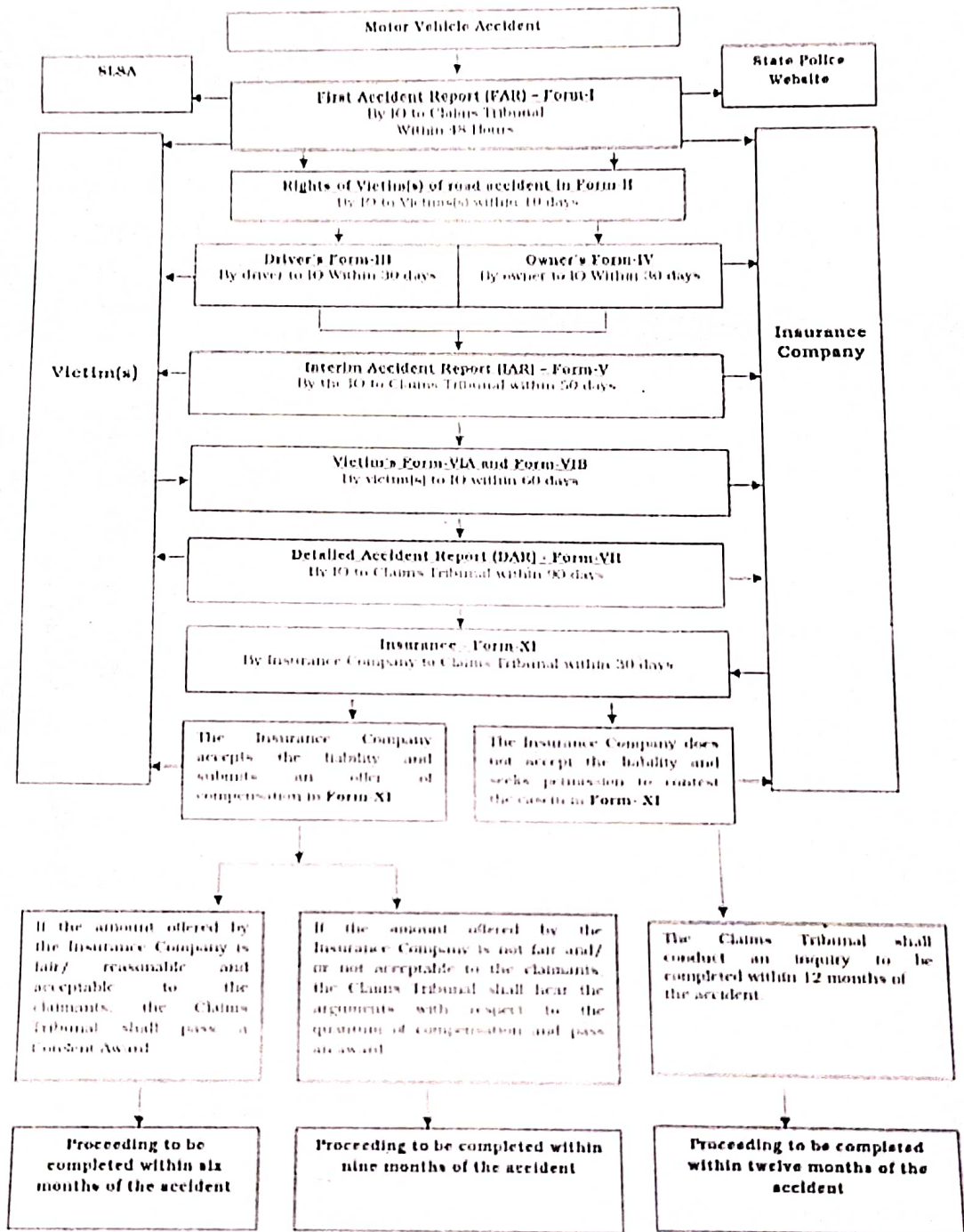

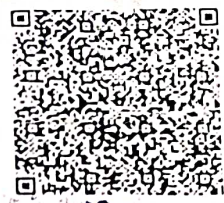
FLOW CHART OF SCHEME FOR MOTOR ACCIDENT CLAIMS

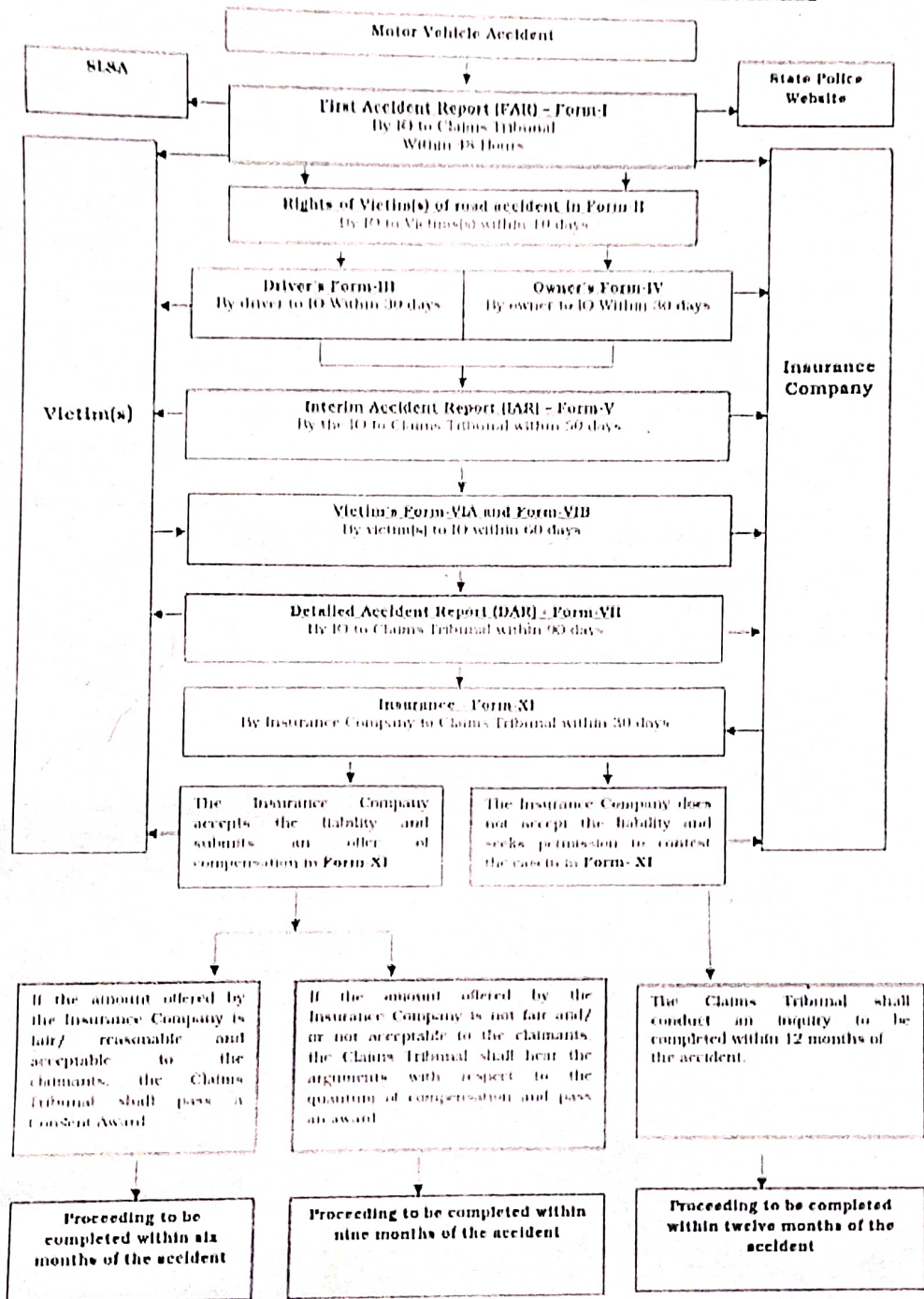

17. **Brief Facts of the case (Add Separate Sheet, if necessary):-** On 04/12/2023 received a written complaint from one Lal bahadur Gupta S/O- Om Prakash Gupta of 10th Mile, Rishi road, PO & PS- Kalimpong Dist- Kalimpong to the effect that on 03/12/2023 at around 11.30 pm one bolero pick up register number WB71B/2302 driven by Dulal Sarkar S/O Lt. Shankar Sarkar of 2no Joti Nagar Iscon Mandir road, Haider para, W.no 40 Siliguri, Dist. Jalpaiguri, Pin-734001 hit his friend near Gaikholra Over which his friend sustained severe injury. After that the driver of the vehicle flew away from the spot. However he manage to locate the driver along with the vehicle at 29th mile where the driver reversed his vehicle and deliberate collided with a complaint's vehicle bearing registration no WB73F/3052 and damaged the vehicle. Over this written complaint started above noted case and endorsed to me O/C Reang PS for its investigation.

During investigation of this case I visited the P.O, prepared rough sketch map of this P.O. along with the index in a separate sheet of papers, examined the available witnesses and recorded their statement U/S 161 Cr.P.C in a separate sheet of paper, I also seized the vehicles bearing no WB-71B/2302 and WB-73F/3052 along with all relevant documents under proper seizure list duly signed by the witnesses. I served notice to accused person Dulal Sarkar U/S 41 Cr.P.C in compliance to the notice appeared at PS and received a voluntarily surrender slip of accused Driver from Ld. Court Kalimpong order sheet no. 02 dated 07/12/2023. I also called a Mechanical expert report of both vehicles where Mechanical expert opined the cause of accident due to as "FROM THE TECHNICAL POINT OF VIEW THE CAUSE OF ACCIDENT OF VEHICLE NO. WB-71B/2302 APPEARS TO BE OTHER MECHANICAL FAILURE" AND "FROM THE TECHNICAL POINT OF VIEW THE CAUSE OF ACCIDENT OF VEHICLE NO. WB-73F/3052 APPEARS TO BE OTHER THAN MECHANICAL FAILURE". I also called injury report of Sumit Gazmer S/O Chand Gazmer of near Kumdini Homes School, Kalimpong. As per kind order sheet of Ld. Court Kalimpong I released both vehicles along with all documents respectively except D/L.

During investigation the prima facie charge u/s 279/337/338/427 IPC has been well established against the F.I.R name accused driver Dulal Sarkar. Hence I consulted the merit of the case with O/C Reang PS and CI Pedong Kalimpong, who after pursuing the case diary pleased to direct me to submit Charge sheet in this case. 
