TENDER NOTICE

Sealed quotations are invited from recognized and reputed firms/dealers having registered trade license for **Miscellaneous Articles** for use in various offices of this unit for the financial year 2019-2020. The terms of contract will be effected from Date of Acceptance up to March 31, 2020, or until further order. Quotation for tender and supply of items by selected firm should be as per following terms:

- Quotation should be submitted in sealed envelope super scribed "**QUOTATION FOR SUPPLY OF MISCELLANEOUS ARTICLES FOR THE YEAR 2019-2020**" and submitted to the office of the undersigned.
- The rates should be furnished item-wise on the broadsheet available at the office of the undersigned. **The rate should not exceed MRP and** shall be inclusive of all charges and taxes, if any. Corrections should be authenticated by full signature.
- The quotation should be submitted by **29.03.2019**. Opening and selection of tender will be done on same day at **3 PM** in the office of the undersigned.
- An **Earnest Money Deposit** of Rs 10,000 (Rupees Ten Thousand only) should be furnished in the shape of DCR/NSC in favor of the **Superintendent of Police, Kalimpong**, along with the quotation. Earnest money deposited by firms selected during the tender process will be retained till expiry of three months from 31.03.2020. The earnest money deposited by firms not selected during the process will be returnable on 01.04.2019.
- Self-attested photocopy of GST documents, Professional Tax documents and Trade License having validity on date of submission of quotation should be furnished along with tender papers. In case of expiry of Trade License during the period 2019-2020, the attested copy of renewed license should be produced at the time of supply of materials.
- The successful firms shall complete delivery of articles within seven days of the date of receipt of Supply Order, failing which Earnest Money Deposit is liable to be forfeited. The supplier concerned will not be considered for further contract and legal action will be initiated.
- Bidders shall arrange for their own transport to and from the office of undersigned on day of submission and opening of quotations, without claiming any extra payment from this department.
- Right of acceptance of tender will rest with the undersigned along with the right to reject or review or divide amongst tenderers without assigning any reasons thereof.
- Samples of items to be supplied shall have to be produced before the undersigned at the time of receiving supply order.
- Brand and other specifications mentioned in broadsheet are illustrative of quality of the product expected. Similar quality with different specifications may also be considered.
- The Superintendent of Police, Kalimpong, reserves the right to forfeit Earnest Money Deposit tendered by bidders or part thereof in the event of failure to fulfill conditions of the contract.

- The Superintendent of Police, Kalimpong, reserves the right to reject lowest quotation or any other quotation, if required, without assigning any reason thereof.


