





16. Brief Facts of the case: (Add separate sheet if necessary): On 20/07/2023 at 08:30hrs received a written complaint from one Bidhya Tamang, D/O-Lt. Mansing Tamang of Suntaley, PS-Reang, Dist-Kalimpong to the effect that one unknown vagabond lady roaming in an around the locality. On 20/07/2023 at around 07:30/08:00hrs he found that her dead body was lying beside N.H-10 near Lohapool Bridge, under Reang PS, Kalimpong whose death was occurred due to an accident. Over this complaint a specific case is registered and on being endorsed the case to ASI Ajay Singh by OC, Reang PS.

During investigation ASI Ajay Singh visited the PO prepared Rough sketch map and Index of the PO, Serve the Notice examine the available witnesses and recorded their statement U/S 161 Cr.PC. Accused driver named Chotu Khan had surrendered before the Ld Court, Kalimpong on 24.07.2023 and release on court bail vide GR No 210/23. On 14.11.2023 as per endorsement by O/C, Reang PS I received made over case from ASI Ajay Singh. Thoroughly go through the case diary from CD I to CD III and found that Seizure, mechanical report and PM report part of the case was left by previous IO.

On 18.01.2024 I received the SCD, PM report, Inquest report, dead body challan and relevant papers of the UD case vide Reang PS UD case 17/23 dated. 20.07.2023 from enquiry officer SI Biswajit Oraw. I seized the vehicle and its documents under proper seizure list. I sent a requisition to Mr. Bholanath Baruri to mechanically examine the offending vehicle and give his valuable opinion. After examining the offending vehicle he opined that "There is no any mechanical failure found at the time of accident".

During investigation a prima facie charge U/S 279/337/304 A IPC has been well established against the FIR named accused driver of Trailer bearing Regn. No-NL01K1967 Chotu Khan s/o Late Nayeem Khan of Jharkhand.

Accordingly I consulted with my superiours O/C, Reang PS and CI, Pedong, Kalimpong regarding merit and demarit of the case. They both instructed me to submit Charge sheet after persuing of case docket. Hence, I submitted Charge sheet against Chotu Khan s/o Late Nayeem Khan of Jharkhand under C/S No. 19/24 dated. the time of Trial. The result of the investigation inform to complainant.
