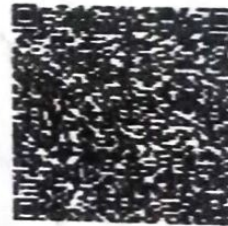



16. Brief Facts of the case : (Add separate sheet if necessary) : The fact of the case in brief is that On 17/10/2023 received a written complaint from one Jigmi Tamang, S/O-Lt. Urgan Tamang of Labdah Division, Mungpoo, Darjeeling to the effect that on 17/10/23 around 15:30hrs one vehicle bearing registration no-WB77A9684 driven by his uncle Buddha Kumar Moktan met an accident near Hanuman Jhora under Reang PS due to front wheel burst. Due to accident 03 passenger got severely injured as well as the vehicle was damaged. Over this complaint a specific case is registered and on being endorsed the case to me by OC, Reang PS, I have taken up its investigation.

During investigation I visited the PO prepared Rough sketch map and Index of the PO, Serve the Notice examine the available witnesses and recorded their statement U/S 161 Cr.PC. I seized the vehicles and its documents under proper seizure list. I sent a requisition to Mr. Bholanath Baruri to mechanically examine the offending vehicle and give his valuable opinion. After examining the offending vehicle he opined that "from the technical point of view the cause of accident appears to be other than mechanical failure". I collected all the 03 (three) injury report accident victims.



The witnesses will prove the case during the time of Trial. The result of the investigation inform to complainant.
