The brief fact of the case is that on 18/9/23 at around 19:15 hrs received a written complaint from one Devanand Tamang 810t Fulbahadur Tamang resident of lower fagu P.S. and block Gorubathan Dist Kalimpong to the effect that on 18/9/23 at about 13:59 hrs one passenger namely Rajen Tamang (55) 810 Kalu Tamang of lower fagu PS UBN Dist KPG fell down from one Tata magic vehicle bearing registration no WB TTA-345T near old DCS office area sustain several injuries on his person. After that with the help of local people shifted him to the Gorubathan Rural Hospital where he succumbed to his injuries. While the offending vehicle coming from Dandin to Sonbarney Bazar the said accident occurred due to rash and negligent driving of the driver. The offending vehicle seized and accused driver of the vehicle arrested. Over this complainant one specific case was registered vide UBN PS case no 28/23 dt 18/9/23 U/S 279/304A IPC and one old case was registered vide Gorubathan PS Old case no 14/23 dt 18/9/23.

During enquiry along with UO of 136 Sanleas Kharka left for Gorubathan BPHC for holding enquiry. During investigation if found that the dead body of deceased Rajen Tamang lying on the iron stretcher at Gorubathan BPHC and his hair colour was black, eyes
